BE IT RESOLVED THAT, one of the missions of KLCU and affiliated organizations is the development and assisting of National and International Ministries to fulfill their vision of Theological Ministerial and related training for their people. KLCU strongly believe in the indigenous principle, that is, that the best people to teach, train and release God's people into effective services through our leaders in the local church. With this in mind, the following principles of agreement are presented to those who choose to affiliate with KLCU as affiliate.

WHEREAS The "Affiliate", hereby agrees to the following:

1. The affiliate school and the director desires to have an ongoing relationship with KLCU as appropriate for networking, development, implementation, assistance and validation of a local educational program.
2. The "affiliate" agrees to abide by the standards of KLCU, to include usage of approval syllabus, textbooks, examinations, curriculum, grading standards etc. and adhere to all policies and procedures as prescribed in KLCU brochure.
3. The affiliate agrees to offer courses that are approved and found in catalog/brochure provided by KLCU.
4. The affiliate will comply with financial arrangement of KLCU, determined at the discretion of the board of Directors.
5. The "affiliate" may choose any name for its school, but must indicate on all literature for promotion and all public pronouncements that the school is affiliated with KLCU.

FURTHER, the "Affiliate" agrees to the following financial arrangement:

1. Affiliation fee of \$500
2. Annual Renewal fee \$200 due on January 30th of each year with school annual report.
3. Certificate printing fee of \$100 per student, per award level.

KLCU agrees to provide the "Affiliate"

1. Permission to provide instruction as a member of KLCU according to the guidelines listed above.
2. Curriculum/ brochure of KLCU for use.
3. Certificate of Affiliation

4. To attend affiliate graduation/matriculation through KLCU representatives in their area.
5. Occasional visit to affiliate through designated National representative.
